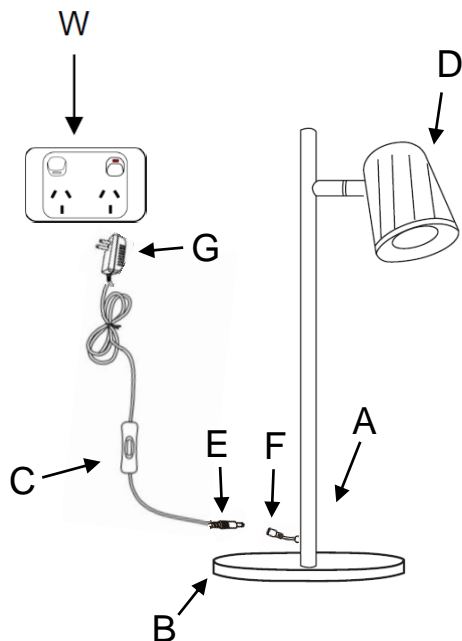


KALLA LED TASK LAMP 21426

Before first using your new Brilliant LED Task Lamp it is most important that you read and follow these instructions, even if you feel you are quite familiar with this type of product. Keep this document handy for future reference.

For your safety

- Do not stare at an operating LED light source.
- During use the light shade becomes hot.
- This LED fitting has no user serviceable parts.
- Do not place in position where the fitting can be easily accessed by children or the infirm.



Assembly Instructions

1. Ensure the wall socket is switched off.
2. Unpack the fitting carefully and place it on a flat surface. Do not plug the lamp into the wall socket yet.
3. Align rod (A) with thread on base (B). And screw rod (A) to the base (B). Make sure tighten firmly
4. Plug male barrel connector (E) into female barrel connector (F)
5. Plug adapter (G) into the selected wall socket (W) and turn the mains power ON.
6. Adjust the LED Lamp (D) into the desired position.
7. Operate the light by using cordline switch (C)
